COVID-19 Guidelines for Legacy Sports Park 2021-

Coaches/team representatives are responsible to monitor their teams' health. If a player has been exposed to the virus or is symptomatic, they cannot participate at any events at the facility.

Fully vaccinated spectators will be able to sit together at outdoor events, social distancing of 6 feet is recommended for unvaccinated people. Vaccinated spectators are not required to wear masks while indoors or when walking around the park. Unvaccinated spectators are advised to continue to wear a face covering indoors and when walking around the park.

It is strongly advised that players/coaches continue to socially distance while in the dugout. Face coverings are encouraged for unvaccinated players and coaches.

We ask that on deck teams wait in the green areas, away from teams and spectators while waiting for the fields to clear. Avoid congestion if possible.

Post-game handshakes should be replaced by the opposing teams lining up on their respective foul lines, properly spaced, and offer a tip of the cap to the opposing team.

Those found violating these guidelines may be asked to leave the park and/or be removed from their spot on a tournament or league.

Please be patient as these guidelines are constantly changing. Thank you for your cooperation and enforcement of these guidelines. The health and safety of everyone utilizing our park is of the utmost importance.
